



PRIVATE RV PARK PET POLICY & LIABILITY WAIVER (INDIANA)

These rules are adopted for the safety and comfort of all guests. They are modeled after Indiana's public-land safety standards (312 IAC 8-2-6) but apply as private-park rules.

PET POLICY

1. Leash & Control Requirements

- All pets must be on a **physical leash no longer than 6 feet** when outside your RV or vehicle.
- Pets must be **attended and under control at all times**.
- Pets may not be tied out or left unattended outdoors.
- Portable pet fencing, kennels, or outdoor enclosures are **not permitted** unless approved by management.
 - This rule aligns with Indiana's public-land standard restricting temporary structures (312 IAC 8-2-10).

2. Waste Disposal

- Owners must **pick up and properly dispose of pet waste immediately**.
- Failure to clean up after pets may result in ejection from the park-no refunds.

3. Behavior Requirements

- Pets must be **non-aggressive** and not pose a nuisance.
- Excessive barking or disruptive behavior is not allowed.
- Any pet showing aggression may be required to leave the park.

4. Restricted Areas

Pets are not allowed in:

- Bathhouses
- Laundry facilities

- Pools or recreation buildings
- Any posted “No Pets” areas

5. Vaccination Requirements

- Proof of **current rabies vaccination** must be available upon request.
- Pets must be free of fleas, ticks, and communicable diseases.

6. Pet Limits

- Maximum of **two pets per campsite**, unless approved by management.

PET LIABILITY WAIVER

By signing below, I acknowledge and agree to the following:

1. **Full Responsibility:** I accept full responsibility for the actions, behavior, and safety of my pet(s) at all times while on park property.
2. **Liability for Damages:** I agree to pay for any damage, injury, or loss caused by my pet(s) to persons, other animals, vehicles, RVs, buildings, or park property.
3. **Indemnification:** I agree to indemnify and hold harmless the RV park, its owners, employees, and agents from any claims, injuries, damages, or expenses arising from or related to my pet(s).
4. **Removal for Safety:** I understand that the RV park reserves the right to require removal of any pet that displays aggression, causes repeated disturbances, or violates park rules.
5. **Compliance with Rules:** I have read and agree to follow the Private RV Park Pet Policy. I understand these rules are private-park requirements modeled after Indiana safety standards (312 IAC 8-2-6) and are enforceable as conditions of my stay.
